Why was ATU conceived? History, mission, purpose...

Brief history

Founded in 1977 as a specialised agency of the Organisation of African Unity, now African Union, in the field of telecommunications. The African Telecommunications Union (ATU) took its present name in 1999. This led to the transformation of the agency into a partnership between public and private stakeholders in the information and communication technology (ICT) sector.

ATU provides a forum for stakeholders involved in ICT to formulate effective policies and strategies aimed at improving access to information infrastructure and services. In addition, the Union represents the interests of its members at global decision-making conferences and promotes initiatives aimed at integrating regional markets, attracting investment into ICT infrastructure, and building institutional and human capacity.

Why we exist

The mission of the Union is to promote the rapid development of info-communications in Africa in order to achieve universal access, and full inter-country connectivity.

The Union envisions an Africa that is empowered as a full and active participant in the global information and knowledge society.

African states...

African states would be delighted to see cross-border connectivity, backbone capacity, universal access and the application of ICT solutions to varied societal issues, all geared to poverty alleviation and economic stimulation.

ATU advocates on behalf of member states for equitable share of globally allocated ICT resources such as frequency spectrums, internet addresses, satellite orbital slots and mobilisation of development funds.

Network operators and service providers...

Integrating regional markets

Achieving continental integration has been a key objective of African leaders since the inception of the Organisation of African Unity, now African Union. More recently, we have seen the emergence of regional economic communities as building blocks towards continental integration.

Larger regional economic-based markets realise economies of scale and lower costs. Integrating regional markets for information and communication technologies (ICTs) requires harmonisation of policy and regulatory frameworks.

Through this programme, ATU works with regional economic communities to harmonise policy and regulatory frameworks. This will enable the creation of larger regional markets for information and communication technologies and increase private sector participation.

Attracting investment into ICT infrastructure

Independently of the current state of a country's economy, the key to future success is access... broadband access for the deployment of information-intensive applications, wireless access for faster deployment of services to the entire population, mobile access to better serve needs of the largest number... access that is affordable for mass use.

But telecommunications in Africa are characterised by a relatively low level of (mostly narrowband) tele-density. With the integration of regional markets, the continent is ripe for rapid growth in tele-density and for the development of new business models based upon these access platforms. This could be realised through smart partnerships between public, private and not-for-profit sectors.

Building human and institutional capacity

While public institutions in Africa are no longer as directly involved in the provision of information and communication technology (ICT) services, they still have an important role to play in development of the private sector, principally to regulate and promote its development. Unfortunately, public institutions in many African countries have not been adequately strengthened to undertake their new functions, due to a lack of funds and other problems.

Our success critically depends on the capacity of individuals and institutions that collaborate with ATU in various core activity programmes.

What we do

Through this programme, ATU facilitates initiatives to build the capacity of individuals and institutions in making treaties, setting standards, formulating policy, drafting regional integration protocols and attracting investment.

To realise our goal, we are...

What has ATU done lately? Highlights of achievements...

Contributing to global decision-making

Contributions for the ITU PP-02: 23 African common proposals (AFCPs) were adopted by the International Telecommunication Union Plenipotentiary Conference (ITU PP-02). In particular...

- one of the resolutions awarded a grant of CHF47,000 to ATU from ITU.
- another resolution on the World Radiocommunications Conference (WRC) preparatory process resulted in the African common proposal drafting process being assured of ITU's support.

Contributions for WRC-03: While participating in the conference preparatory meeting held in Geneva, a strategy for evolving AFCPs for WRC-03 was crafted. As a result, the Africa region meeting on information and preparation for WRC-03 generated 54 AFCPs.

Integrating regional markets

ATU has signed cooperation agreements with regional economic communities affiliated to the African Union. And to support initiatives aimed at promoting regional market integration, ATU participated in a number of policy harmonisation meetings.

One such meeting was held in August 2002 in Nairobi. The objectives of the meeting were to discuss interconnection, licensing and universal service/access in general terms. Participants also drafted policy guidelines and model regulations in specialist areas.

Attracting investment into ICT infrastructure

ATU has catalysed effective collaboration leading to the establishment of regulatory associations within the Common Market for Eastern and Southern Africa (COMESA) and the Economic Community for West African States (ECOWAS). These are the Association of Regulators for Information and Communication Services of Eastern and Southern Africa (AFRICEA), and the West African Telecommunications Regulators Association (WATRA) respectively.

Other specific achievements include...

- Successful negotiation for the Regional African Satellite Communication Organisation (RASCOM) orbital slot at 2.9*E with the period of satellite filings extended from January 2005 to January 2008.
- Launching of the pre-feasibility study of the East African Submarine Cable.

Building human and institutional capacity

ATU in collaboration with the International Amateur Radio Union successfully organised an amateur radio administrative course. The course was attended by 22 participants drawn from Anglophone countries and radio amateur societies.

Another course for Francophone countries is planned.

Managing membership relations

Coordination of membership relations: A membership relationships management system has been developed at the secretariat to facilitate closer tracking of service delivery.

Information and knowledge sharing: The secretariat has launched a new information bulletin "Access" and published a continental directory. An information resource centre has also been established at the secretariat.

Development of ICT database: ATU has developed an information and communication technology database depicting key continental indicators.

Development of information systems: The secretariat has developed various systems to enhance performance...

- ATU stakeholder relationship database
- Electronic document directory system
- Electronic financial records

The Conference of Plenipotentiaries, is the supreme authority of the Union, and meets every four years to adopt the strategic plan and the fundamental policies of the organisation. The Conference also decides on the organisation and activities of the Union.


The Administrative Council meets annually to consider broad policy issues in order to ensure that the Union's policies and strategies fully respond to the constantly changing infocommunication environment. The Council is also responsible for ensuring the efficient coordination of the work of the Union and the approval of budgets.

The Technical and Development Conference provides an opportunity for all stakeholders to examine policy, operational, regulatory, technical and investment related issues necessary for the rapid development and expansion of infocommunications on the continent.

The General Secretariat headed by the secretary general, handles all the administrative and financial aspects of the Union's activities. Each core activity programme has a coordinator. In addition, there is a membership relationship coordinator who ensures that the secretariat meets the changing needs and expectations of the membership in an efficient and sustainable manner.
