Press Statement

The Conference of Plenipotentiaries of the African Telecommunications Union (ATU) held in Abidjan, Cote d'Ivoire from 26 - 27 August 2003 elected Mr. Akossi Akossi, Secretary General of the Union for the period 2004 - 2006. JAN MUTAI – BRIEF RÉSUMÉ

Mr Jan MUTAI is the outgoing Secretary General of African Telecommunications Union (ATU), a specialised agency of the African Union (AU), in the field of Telecommunications. He was elected to this position on 7th December 1999, at the Extraordinary Session of the Conference of Plenipotentiaries of the Union, held in Cape Town, South Africa. He has successfully completed his four year term of office in which he repositioned ATU, as one of the leading intergovernmental organisations in Africa, fostering accelerated development of information infrastructures and services. Through his contribution and those of others, there is now more affordable access in Africa, to the benefits of the emerging information society especially through mobile networks and services.

He handed over office today to Mr. Akossi Akossi, a national of Cote d'Ivoire at a ceremony presided over by Hon. John Michuki, MP, the Minister of Transport and Communications who is also Chairman of ATU Conference of Plenipotentiaries. Mr. Akossi Akossi was elected to this office by the Conference in August last year in Abidjan, Cote d'Ivoire.

Mr. MUTAI has built-up extensive experience, both in the public and private sectors, especially in the fields of public sector reform, business strategy, organisational restructuring, and process re-engineering. In his next career move, he intends to use the considerable skills, knowledge and experience to provide consultancy services to clients in the ICT and energy sectors through his start-up consultancy form - *Jan Mutai & Associates*. He was previously, Managing Director of Kenya Posts and Telecommunications Corporation (KP&TC). Whilst there, he laid the foundation for the reform and restructuring of the telecommunications sector, resulting in new legislation in 1998, for the separation of powers, for policy, regulation and service provision. As a result KP&TC was split in 1999 into three entities; namely the Communications Commission of Kenya (CCK), Telkom Kenya Limited and the Postal Corporation of Kenya. For his contribution to national development, he has been honoured by the Republic of Kenya with several awards, which include the Head of State Commendation (HSC) and the Elder of the Burning Spear (EBS).

Before appointment in the public sector, he had over 20 years experience in the business sector, with the Shell group of companies, where he rose through the ranks, from a plant engineer, through sales & marketing management, to director human resources & public affairs. Jan MUTAI is a member of the Institution of Engineers of Kenya and other professional organisations.
